### ACM-BCS Visions of Computer Science 2010 Conference 13-16 April 2010, Edinburgh University.

CPHC has been working with the BCS and the ACM to finalise the conference schedule. ### BCS Academy of Computing

As a founder member of the Academy along with UKCRC and BCS, CPHC has been helped develop the terms of reference for the Academy Board and its three new sub-committees, which cover Research, Education (which it leads on) and Science & Engineering Engagement. It is now seeking to populate the membership of these committees with a view to holding the first Academy Board meeting in late Jan / early Feb 2010. The Academy has already identified two strategic partners, HEA and CAS (Computing and Schools Group), which it is now working with closely on a number of agendas. You may recall considerable discussion at the last CPHC conference about the Locate IT project which was essentially a website designed to broker partnerships between industry and academia for any type of useful link from research bids, to finding a guest lecture from industry on a particular topic. CPHC has been working with EURIM (The European Information Society Group who are an independent UK based Parliament-Industry group funded by its members) to support their competition to create a 3 minute video to education MPs on the topic of Information Governance. CPHC has been working with the BCS and e-skills UK on the agenda to revise the GCSE ICT curriculum. We are attending a meeting on Feb 4<sup>th</sup>, hosted by the Royal Society, to bring together interested parties to discuss a way forward.

#### **Computing at Schools**

We are working with CAS and the BCS Academy to help organise a number of regional conferences for sixth form students (+ Year 11) next term. The number of conferences planned to-date is well into double figures. #### **Meeting with e-skills UK**

CPHC representatives met with e-skills UK on 10<sup>th</sup> Sept 2009 to discuss mutual interests. This was an extremely positive meeting and CPHC is looking forward to working with them on a number of agendas including their National Skills Academy for IT which is due to launch in the autumn of 2010 and has the remit of brokering and providing information on CPD for people already employed in the IT industry.
